Dayview Textiles Pty Ltd reserves the right to charge interest on any overdue account, charged at the bank's lending rate at the time the moneys fell due. Returns/credit notes will be issued for the following reasons only. (1) Faulty goods. (2) Incorrect goods supplied. (3) Damaged goods. Permission must be obtained from Dayview Textiles P/L prior to the return of any goods for credit and a return number obtained. Without a return number goods may not be credited. A copy of the invoice must accompany any returned goods. No credit will be issued after a period of 30 days from date of invoice, unless goods found to be faulty. If faulty the goods are to be returned to Dayview Textiles P/L unless otherwise advised.

Retention of Title: All goods remain the property of Dayview Textiles P/L until paid in full by the purchaser.

Freight charges will apply for all deliveries. All goods are checked prior to despatch, we ask customers to check all deliveries within five (5) days of receipt, as no claims for shortages will be recognised after these (5) days have elapsed. Any goods that have been cut may not be returned for any reason.
